## **Identity and Contact Details of the Data Controller**

#### Purposes and Legal Bases for Processing

- **A. Management of Information Requests:** personal data are processed for all purposes related to the handling and fulfilment of requests for information and/or quotations.
- **B. Defensive Purposes:** The Data Controller may need to process personal data for the management of disputes and for the handling of pre-litigation or litigation matters, whether judicial or extrajudicial.

#### **Scope of Data Disclosure**

Personal data are processed by internal personnel duly authorised for specific tasks and may be disclosed externally in accordance with the following rules.

#### Purpose Categories of External Recipients

A. Companies belonging to the same corporate group; commercial agents; business consultants; authorised resellers

**B.** Law firms; debt collection or credit transfer companies; judicial authorities.

Since the data are also processed using electronic tools, they may likewise be accessible to entities providing support, hosting, or maintenance services for such systems.

#### Transfer of Data to a Third Country or an International Organisation

#### Data Subjects' Rights

The individual to whom the personal data refer is granted the following rights:

Access: the data subject has the right to obtain confirmation as to whether or not personal data concerning them are being processed, and, where that is the case, to access such data and request a copy thereof.

**Rectification:** the data subject has the right to request the updating of their personal data, the correction of inaccurate data, and the completion of incomplete data.

**Erasure**: the data subject has the right to obtain the erasure of their personal data under certain conditions (for further information, please contact the Data Controller).

**Restriction of Processing:** the data subject has the right to request that their data be marked in order to restrict further processing under certain conditions (for further information, please contact the Data Controller).

**Objection**: the data subject has the right to object to the processing of their personal data, on grounds relating to their particular situation, where such processing is based on the legitimate interests pursued by the Data Controller or is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Data Controller.

**Data Portability:** The data subject has the right to receive, in a structured format, the personal data they have provided to the Data Controller, and to request that such data be transmitted to another data controller, where the processing is based on consent or a contract and is carried out by automated means.

**Withdrawal of Consent**: The data subject has the right to withdraw their consent for the purposes that required it, without affecting the lawfulness of processing carried out prior to such withdrawal.
